PURPOSE OF THIS EXHIBIT

This email chain establishes the complete chronology of Rae Dorsey's preschool enrollment at Nederland Elementary School. It shows: (1) BVSD initiated contact with Petitioner regarding enrollment deadlines; (2) Petitioner attempted to complete enrollment on May 29, 2026 — the same date Petitioner filed her motion — and encountered a "duplicate student" error; (3) BVSD confirmed in writing on June 8 that the duplicate was caused by Respondent having already registered Rae in SchoolMint; and (4) BVSD corrected the issue and completed Rae's placement at Nederland.

KEY PASSAGE — June 8, 2026 (Liliana Luces to Richard Dorsey):

"We were able to add Rae to your SchoolMint profile. However, you were unable to proceed because Mrs. Lola had accidentally started an enrollment application for the K-12 program rather than the preschool program."

Note: "Mrs. Lola" refers to Respondent Lauren Dorsey. Respondent's enrollment application in SchoolMint created the "duplicate student" error that prevented Petitioner from completing his Nederland enrollment.

Please collect the following documents before starting the SchoolMint registration:

- Proof of age for your child (birth certificate, etc.)
- Proof of residence
- Your student's most recent physical
- Your student's most recent immunizations

- Medical provider information (pediatrician, dentist, preferred hospital)

- Emergency contact information — at least one person who is not a legal guardian

Please note that you must be the legal guardian in order to enroll your student into BVSD.

Hello Mr. Rich,

I'm glad to see that you're making progress with Rae's application!

1. UPK has received Rae's application. Please check your email and accept the placement offer at Nederland Preschool. Once you accept the offer, we will be able to determine whether Rae qualifies for 15 free hours (Half Day) or 30 free hours (Full Day) through the UPK program.

If Rae does not qualify for the additional 15 hours, the tuition for Full Day preschool would be \$785 per month for those extra hours.

If you believe your family may qualify for financial assistance, we should complete an income verification during our meeting tomorrow. For a household of 3, the annual income must be below \$70,622.50 to be eligible.

2. I noticed that the SchoolMint application has not yet been completed. This is where you'll need to upload documents such as Rae's Birth Certificate, Physical Exam form, and Proof of Residency.

If possible, please try to complete this today so that we can continue moving forward during our meeting tomorrow.
